

**CORPORATION OF THE COUNTY OF PERTH  
BY-LAW NUMBER 2881**

**A By-law of the Municipal Corporation of the County of Perth appointing officials to various boards and commissions as designated by the Striking Committee report dated December 2, 2004.**

**WHEREAS** the Perth County Council Striking Committee at their December 2, 2004 meeting presented a report to Perth County Council which was subsequently adopted at their December 2, 2004 meeting; and

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE COUNTY OF PERTH enacts as follows:

**THAT** George Wicke is appointed as a member of the Land Division Committee until November 30, 2006.

**THAT** Calvin Strathdee is appointed as a member of the Land Division Committee until November 30, 2006.

**THAT** Rae Bender is appointed as a member of the Land Division Committee until November 30, 2006.

**THAT** Arnold Siroen is appointed as a member of the Land Division Committee until November 30, 2006.

**THAT** Ronald Boyce is appointed as a member of the Land Division Committee until November 30, 2006.

**AND WHEREAS** the Municipal Act provides that a Municipal Council may appoint members to an Archives Board.

**THEREFORE**, the Council of the Corporation of the County of Perth hereby enacts as follows:

**THAT** Councillor Greg Marles is appointed for a 1-year term to hold office until November 30, 2005.

**THAT** Councillor Gerald Wallis is appointed for a 1-year term to hold office until November 30, 2005.

**THAT** Councillor Ronald McKay is appointed for a 1-year term to hold office until November 30, 2005.

**AND WHEREAS** the County Road System for the County of Perth has been established under the Highway Improvement Act and it is desirable to appoint persons resident of the County of Perth, who shall constitute a committee for the purpose of directing the work in the County Road System.

**THEREFORE**, the Council of the Corporation of the County of Perth hereby enacts as follows:

**THAT** all members of County Council sit on the Public Works Committee for a 3-year term expiring November 30, 2006.

**WITH RESPECT** to the Corporate Services Committee, the Land Ambulance Committee, and the Community Services Committee the Council of the Corporation of the County of Perth enacts as follows:

**THAT** all members of the County Council sit on the Corporate Services Committee, the Land Ambulance Committee, and the Community Services Committee for a 3-year term expiring November 30, 2006.

**AND WHEREAS** the Homes for the Aged and Rest Homes Act states that the Councils of the Municipalities establishing and maintaining a joint home shall appoint from among the members of the Councils a Committee of Management.

**THEREFORE**, the Council of the Corporation of the County of Perth hereby enacts as follows:

**THAT** Warden Ed Hollinger is hereby appointed for a 1-year term.

**THAT** Councillor Carl Gingerich is hereby appointed for a 1-year term.

**AND WHEREAS** under authority of the Health Protection and Promotion Act, the Board of Health of the Perth District Health Unit shall have six municipal members with three members to be appointed by the Municipal Council of the County of Perth.

**THEREFORE**, the Council of the Corporation of the County of Perth hereby enacts as follows:

**THAT** Councillor Julie Behrns is hereby appointed for a 1-year term,

**THAT** Councillor Barb MacLean is hereby appointed for a 1-year term.

**THAT** Councillor Ian Forrest is hereby appointed for a 1-year term.

**AND WHEREAS** it is desirable for Perth County Council to appoint members to other boards, commissions and associations.

**THEREFORE**, the Council of the Corporation of the County of Perth hereby enacts as follows:

**THAT** Warden Ed Hollinger is hereby appointed to the Municipal Liaison Committee for a 1-year term expiring November 30, 2005.

**THAT** Councillor Barb MacLean is hereby appointed to the Municipal Liaison Committee for a 1-year term expiring November 30, 2005.

**THAT** Councillor Ian Forrest is hereby appointed to the Municipal Liaison Committee for a 1-year term expiring November 30, 2005.

**THAT** Councillor Julie Behrns is hereby appointed to the Community Services Advisory Committee for a 1-year term expiring November 30, 2005.

**THAT** Councillor Ronald McKay is hereby appointed to the Community Services Advisory Committee for a 1-year term expiring November 30, 2005.

**THAT** Councillor Gerald Wallis is hereby appointed to the Stratford-Perth Museum Association Board of Directors for a 1-year term expiring November 30, 2005.

**THAT** Amos Gerber is hereby appointed to the Spruce Lodge Non-Profit Housing Authority until November 30, 2006.

**THAT** Councillor Greg Marles is hereby appointed to the Perth County Joint Accessibility Committee for a 1-year term expiring November 30, 2005.

**THAT** Judy Nafziger is hereby appointed to the Perth County Joint Accessibility Committee for a 3-year term expiring November 30, 2006.

**THAT** Ethel Sage is hereby appointed to the Perth County Joint Accessibility Committee for a 2-year term expiring November 30, 2006.

**THAT** Jim Spence is hereby appointed to the Perth County Joint Accessibility Committee for a 2-year term expiring November 30, 2006.

**THAT** Carol Francis is hereby appointed to the Perth County Joint Accessibility Committee for a 2-year term expiring November 30, 2006.

**THAT** Mary McLagan is hereby appointed to the Perth County Joint Accessibility Committee for a 2-year term expiring November 30, 2006.

**THAT** Jason Robinson is hereby appointed to the Perth County Joint Accessibility Committee for a 2-year term expiring November 30, 2006.

**THAT** this By-Law shall be in force upon the final passing thereof until such time as the By-Law is

repealed.

**THAT** By-Law Number 2835 is hereby repealed with the passage of this By-Law.
