BY-LAW NUMBER 2942

AUTHORIZE THE EXECUTION OF AN AGREEMENT FOR PROSECUTORIAL SERVICES

WHEREAS the County of Perth is responsible for administering the Provincial Offences Act including court administration; and

WHEREAS it is necessary for the County to provide prosecutorial services in the Provincial Offences Court.

NOW THEREFORE, the Municipal Council of the Corporation of the County of Perth enacts as follows:

1. That the agreement with S.T.T.D. c/o Walter D. Purdy for the provision of Prosecutorial Services dated March 13, 2006 be executed.
2. That the Warden and the Clerk are authorized to execute the said agreement and to affix the corporate seal thereto.

Read a third time and finally passed this 16th of March 2006.

Terms and Conditions of Contract

- I. Rate of Pay:** \$61.89 per hour (minimum monthly fee (2,000.00) paid monthly (no benefits))
- II. Appointment Effective:** March 13, 2006
- III. Date Appointment Terminates:** March 12, 2007
- IV. Hours:** As required by Provincial Offences Court
- V. Days:** As required by Provincial Offences Court
- VI. Termination:** This contract can be terminated by either party giving (1) month notice, except in the case of dismissal for cause or breach of this contract, where no notice need be given.
- VII. Description of Duties:** The duties include but are not limited to the Prosecutorial Standards attached as Schedule 1.

The prosecutor shall be included in the Corporation's liability insurance coverage for the duration of the term of this Agreement provided that the prosecutor fulfills his duties as set out herein.
