

CORPORATION OF THE COUNTY OF PERTH

BY-LAW NUMBER 2980

A By-Law of the Municipal Corporation of the County of Perth establishing Remuneration for Council in their capacity as members of Perth County Council.

WHEREAS Section 283 provides for the passing of by-laws for the paying of remuneration and expenses to members of Council;

AND WHEREAS it is expedient to establish criteria for remuneration eligibility as that applies to duties and responsibilities of Council,

THEREFORE, THE COUNCIL OF THE CORPORATION OF THE COUNTY OF PERTH HEREBY ENACTS AS FOLLOWS:

THAT the Warden's Honorarium will be a total of thirteen thousand, two hundred and five dollars and sixty-four cents (\$13,205.64) for the additional responsibilities of Head of County Council, for attendance at twenty-two (22) sessions of County Council and for attendance at all social or public functions as County Warden.

THAT the remaining members of County Council will be paid a total of five thousand one hundred and twenty-six dollars and four cents (\$5,126.04) for their responsibilities as County Councillors and for attending twenty-two (22) County Council sessions.

THAT Members of County Council who are absent for more than one meeting in the current year, for other than illness or bereavement, his/her remuneration will be adjusted at the full day or half day rate, whichever applies.

THAT the Warden and each member of County Council appointed to any of the following Committees or Boards will be paid a rate of \$138.57 for meetings over 3 hours and \$91.53 for meetings under 3 hours: Perth District Health Unit, Municipal Liaison Committee, Stratford-Perth Archives Board, Perth County Accessibility Committee, Community Services Advisory Committee, Stratford – Perth Museum Board.

THAT the Warden and each member of County Council attending budget meetings or any other special meetings called pursuant to the Council Procedural By-law will be paid a rate of \$138.57 for meetings over 3 hours and \$91.53 for meetings under 3 hours.

THAT the Warden will attend all public functions when requested, and if deemed warranted, or if unable to attend, that the Warden will delegate someone to represent him/her, who will be compensated at the day rate or half day rate (whichever applies), and that all such activities will be included in the Warden's monthly report to County Council.

THAT the Warden's spouse will be reimbursed for any transportation cost and registration costs when accompanying the Warden to conventions and/or municipal functions.

THAT each member of County Council will be paid 42 cents per km when using their personal vehicle to attend Council Session, duly appointed Committee or Board Meetings or any other pre-approved County business such as Professional Development Workshops, Seminars or Conferences.

THAT honorariums shall be indexed annually to match any percentage adjustment provided to employees.

All rates set out in this by-law shall be effective September 1, 2006

This by-law shall come into force upon the final passing thereof.

Read a first and second time this 10th day of August, 2006.

Read a third time and finally passed this 10th day August 2006.
