

**CORPORATION OF THE COUNTY OF PERTH
BY-LAW NUMBER 3117**

A By-law of the Municipal Corporation of the County of Perth appointing persons to various boards and committees.

WHEREAS Perth County Council at their December 21, 2006 meeting enacted By-law 2998, being a by-law appointing officials and certain citizens to various boards and committees for various terms;

AND WHEREAS Perth County Council at their December 20, 2007 meeting enacted By-law 3060, being a by-law to amend By-law 2998 and appoint officials and certain citizens to the various boards and committees for a further one year period ending on November 30, 2008;

AND WHEREAS Perth County Council at their October 2, 2008 meeting enacted By-law 3104, being a by-law to amend By-law 2998 to change the appointment to the Land Division Committee;

AND WHEREAS Perth County Council at their December 4, 2008 meeting recommended appointments to various boards and commissions;

AND WHEREAS it is deemed appropriate to consolidate previous by-laws and amendments and bring appointments into line with Procedural By-law 2970 as amended by By-law 3115;;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE COUNTY OF PERTH enacts as follows:
