

**CORPORATION OF THE COUNTY OF PERTH
BY-LAW NUMBER 3168-2009**

By-law of the Municipal Corporation of the County of Perth appointing officials to various boards and committees as designated by Perth County Council minutes

Recitals

1. Perth County Council at their December 3, 2009 meeting recommended appointments of officials to various boards and commissions;
2. Perth County Council at their December 18, 2008 meeting enacted By-law 3116, being a by-law appointing officials to various boards and committees;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE COUNTY OF PERTH enacts as follows:

1. Under the authority of the Homes for the Aged and Rest Homes Act, Councils of the Municipalities establishing and maintaining a joint home shall appoint from among the members of the Councils, a Committee of Management.
