**A BY-LAW TO AWARD GRASS CUTTING SERVICES CONTRACT TO STRATFORD
PROPERTY CARE INC.**

June 2, 2016

WHEREAS the Corporation of the County of Perth is desirous of awarding a contract for three seasons for grass cutting services at various Perth County facilities, beginning in 2016 and ending November 1, 2018;

AND WHEREAS Sections 8, 9, and 11 of *Municipal Act, 2001, S.O. 2001, c.25*, as amended authorizes council to enter into agreements;

AND WHEREAS Subsection 5(1) of the *Municipal Act, 2001, S.O. 2001, c.25* as amended, provides that the powers of a municipality shall be exercised by council;

AND WHEREAS Subsection 5(3) of the *Municipal Act, 2001, S.O. 2001, c.25*, as amended, provides that a municipal power shall be exercised by by-law, unless the municipality is specifically authorized to do otherwise;

NOW THEREFORE, the Council of the Corporation of the County of Perth enacts as follows:

1. THAT the Corporation of the County of Perth enters into a contract with Stratford Property Care for grass cutting services at county owned facilities in the City of Stratford, the Township of Perth East, the Municipality of North Perth, and the Municipality of West Perth;
2. THAT Stratford Property Care provide grass cutting services at county owned properties in Stratford, including the Public Works Stratford Yard, the Stratford-Perth Archives, and the Paramedic Services Headquarters and Stratford Base, in the amount of \$150/cut + HST inclusive of the above listed properties;
3. THAT Stratford Property Care provide grass cutting services at county owned properties in West Perth, including the Public Works Mitchell Yard and the Paramedic Services Mitchell Base, in the amount of \$60/cut + HST inclusive of the above listed properties;
4. THAT Stratford Property Care provide grass cutting services at county owned properties in Perth East, including the Public Works Milverton Yard and the Paramedic Services Milverton Base, in the amount of \$45/cut + HST inclusive of the above listed properties;

5. THAT Stratford Property Care provide grass cutting services the county owned property in North Perth of the Paramedic Services Listowel Base, in the amount of \$45/cut + HST;
6. THAT the Director of Public Works be authorized to execute all documents necessary on behalf of the County of Perth.
7. THAT this by-law shall come into force and take effect on the date of final passage.

Read a first and second time this 2nd day of June, 2016.

Read a third time and finally passed this 2nd day of June, 2016.
