## 5.1 Perth District Health Unit – Randy Brown, Miriam Klassen, Julie Pauli

Randy Brown, Business Administrator, presented the 2014 Perth District Health Unit Budget Report as circulated with the Agenda.

#### 5.2 Spruce Lodge – Lorraine Wheal, Peter Bolland

Peter Bolland presented the 2014 Spruce Lodge Budget Report as circulated with the Agenda.

## 5.3 Stratford-Perth Museum – John Kastner, David Stones, Howard Famme

John Kastner, David Stones and Howard Famme presented the 2014 Stratford-Perth Museum Budget Report as circulated with the Agenda, with an updated version circulated today at the meeting.

Motion by Tom Clifford, seconded by Bob Wilhelm THAT the Municipal Liaison Committee recommends to their respective Councils the 2014 budget, as presented by the Stratford-Perth Museum. Carried.

Tom Clifford requested clarification on the significant increase of approximately \$500,000 as the assessed value of the property. John Kastner explained that the current reassessment received this week, is only now reflecting the extensive renovation completed in 2008. Mayor Mathieson inquired if the Museum had an accrual plan in place for the increase in property taxes for the extensive renovation. He also inquired if they felt the assessment was accurate for their property. Howard Famme explained that, in his opinion, the assessment does not accurately reflect a realistic resale value. Mayor Mathieson suggested appealing the assessment and offered to help with the process. Initially a letter will need to be drafted to the township to begin the appeal process. The deadline for the appeal is December 20, 2013.

Vince Judge reported that the County is under pressure for the next few years with a 10% reduction from the Province and is currently reviewing their budgets and need to make drastic changes as they are now pressed for funds.

Mayor Mathieson requested that they schedule a future meeting between himself, Ron Shaw, Museum representatives and the County to discuss the appeal.

## 5.4 Stratford-Perth Archives – Betty Jo Belton

Betty Jo Belton presented the Draft 2014 Stratford-Perth Archives Budget Report as circulated with the Agenda.

She updated members that the new projected completion date for the new facility is Spring 2014 with occupancy by the Fall of 2014, as well, the original cost projected for the facility has been reduced from \$2.75M to \$2.5M.

Motion by Bob Wilhelm, seconded by Bonnie Henderson THAT the Municipal Liaison Committee recommends to their respective Councils the 2014 budget, as presented by the Stratford-Perth Archives. Carried.

#### 5.5 Provincial Offences – Linda Becker
